- Compulsory Radio Purchase : **Once off radio cost of R2 070 for your two-way radio.**
- Bank details : Farm Comm, Absa Bank, Branch Code 632005, Account 9227910071, reference is your name. Please note that new memberships will only be activated once both radio and membership payments are reflected in the FC account.
- Minimum Membership Obligations :
 - a) Night patrol is on a rotational basis either in the FC vehicle or in your private vehicle. Patrol shifts approx. every 7 weeks for 3 hours.
 - b) Day patrol is an option for those with flexible hours, please advise the Secretary should you wish to take this option.
 - c) Partners allocated by FC Secretary on a random basis. If you wish to patrol with your spouse / partner please advise the Secretary.
 - d) All members, irrespective of membership type, are required to assist our community in times of need in different ways.
- In exceptional circumstances we will accept non-participating membership at R1500 per annum on the same sliding pro-rata scale as above. This membership is for members who have compelling reasons for not being able to take part in patrols – please discuss with the Secretary.
- You need to reside in the Farm Comm geographical area to be a member.
- Gate Sign Boards : These are boards placed at entrance to your property to enable additional identification in times of need – cost R70. Please advise the Secretary should you wish to order board/s.
- Insurance: Members are responsible for insurance of property, personal indemnity, medical cover for the member and his/her family, whilst doing voluntary service for Farm Comm. The member agrees not to hold Farm Comm Port Elizabeth liable for any damage to member's property, injuries to member and his/her family, loss of life of member and his/her family, in executing their voluntary services to Farm Comm Port Elizabeth.
- Farm Comm abides with POPIA regulations. A copy of our compliance will be sent with membership confirmation.
